### **Ms. Mama Fatima Singhateh** **Special Rapporteur on the sale and sexual exploitation of children**

Ms. Mama Fatima Singhateh (The Gambia) was appointed as the UN Special Rapporteur on sale and sexual exploitation of children by the UN Human Rights Council in March 2020. She started her mandate on 1 May 2020. Ms. Singhateh is a trained lawyer with over 20 years of experience, currently working as an international Consultant on human rights and legal and institutional reforms. She holds a master's degree in International Business Law from the University of Hull and has undergone numerous trainings in child rights programming, arbitration and mediation, and legislative drafting. She is a member of the Honourable Society of Lincoln's Inn, in the UK.

Ms Singhateh has held a number of high-level positions in public service in the Gambia. She is a former Justice Minister and has held positions as prosecutor, legislative draftsman, High Court Judge and Justice of Appeal. She has drafted laws, organised and conducted many training sessions, delivered presentations at both national and international fora and written articles and reports on many issues relating to protection and promotion of human rights, particularly on the rights of the child. As Minister of Justice, Ms Singhateh personally supervised and oversaw the drafting of the laws that prohibit and criminalise female genital mutilation and child marriage, and successfully presented them in Parliament for enactment in 2016.

Between 2002 and 2007, she headed the Child's Rights Unit within the Ministry of Justice, which was established to enhance the promotion and protection of the rights of children in The Gambia, particularly the girl child. Ms. Singhateh also served as project coordinator within the Ministry for the UNICEF–Government of The Gambia Country Programme of Cooperation. As project coordinator she was also chairperson of the technical advisory committee which under her leadership oversaw the successful drafting and enactment of the Children's Act, the implementation of the Children's Act, the establishment of the Children's Court, and the drafting of the Trafficking in Person Bill (now Act).

Ms. Singhateh has served as a member of the Board of Directors of Ecpat International in Thailand and the Chairperson of the Board of Directors of the Child Protection Alliance in The Gambia. She has also served as a nominated member and legal advisor to the National Women's Council in The Gambia.



**Ana Belen Muñoz Romay, Private Sector Engagement Manager, Fundación Munasim Kullakita, Bolivia**

Ana Belen Muñoz Romay has a Master's Degree in Sustainable Tourism and extensive experience working with populations in social vulnerability. She works as the Private Sector Engagement Manager for the Munasim Kullakita Foundation in Bolivia, where she focuses on children's protection in the context of travel and tourism, providing technical support to partners and local stakeholders to develop prevention strategies. The Munasim Kullakita Foundation promotes social inclusion based on the participative interaction of the community and public institutions, including advocacy and community work. They also provide protection to children victims of sexual exploitation and trafficking.

### **Antje Monshause**

#### **Head of Sustainability and Economic Development Desk, Brot fuer die Welt (Bread for the World)**

Antje Monshausen holds a Diploma in Geography, with political science and public health as minor subjects. She has research experiences in Guatemala and Bolivia, and conducted various projects, and activities with different organisations in Africa, Asia and Latin America. For ten years (2012-2022) Antje Monshausen was head of [Tourism Watch](#), a specialised unit at [Brot fuer die Welt](#) on tourism and development. She is chairwoman of the international multi-stakeholder initiative Roundtable Human Rights in Tourism e.V, vice-chair of the children's rights organisation ECPAT Germany, and a member of the certification council of TourCert. Further, she is active in the international "Transforming Tourism Initiative" in which civil society organisations from all around the world are demanding the transformation of tourism in line with the 2030 Agenda for Sustainable Development.

**Chief Executive Officer, PACT - Protect All Children from Trafficking**

Lori Cohen joined PACT in November 2019 after founding and leading a legal services program that assisted survivors of international and domestic sex trafficking and related forms of gender-based violence. In addition to supervising a coordinated legal, clinical, and case management team to provide comprehensive care, Lori engaged pro bono attorneys from New York's leading law firms, law students, and volunteers; and coordinated with city, state, and federal law enforcement, domestic violence shelters, and social service providers. Lori has garnered international recognition for her work and has drawn upon her experience representing victims to advocate for anti-trafficking policy on federal, state, and local levels. She has conducted trainings in the U.S. and abroad for attorneys, prosecutors, judges, health care professionals, and private industry leaders and taught at Yale University and the University of Michigan Law School.

**Senior Technical Advisor, Better Care Network**

Rebecca is the Senior Technical Advisor for Better Care Network, the preeminent information hub and global convenor to influence action for children without parental care. Rebecca has 22 years' experience working in the international development and child protection sectors, focusing on care reforms, transitioning residential care services, and combatting orphanage trafficking and orphanage tourism. Rebecca is the co-founder of ReThink Orphanages Network Australia and co-chair of ReThink Orphanages Global. Rebecca is also a member of the Australian Institute of Criminology's expert advisory group for the monitoring of the Australian Government National Action Plan to Combat Modern Slavery and the Australian Institute of Criminology's Human Trafficking and Modern Slavery Research Network. Rebecca is the co-chair of several

expert working groups under the Transforming Children's Care Global Platform, including the Transitioning Residential Care Working Group, and Orphanage Tourism, Voluntourism and Trafficking Task Force. Rebecca holds post graduate degrees in International Development and Anthropology and is a PhD in Law Candidate with Griffith University Australia. Her primary research areas include child institutionalisation, deinstitutionalisation, orphanage tourism/voluntourism and orphanage trafficking.

**Guillaume Landry**

**Executive Director, ECPAT International**

Guillaume Landry is the Executive Director of ECPAT International. He has over two decades of professional experience in the field of organisational development, interagency collaboration, and multidisciplinary research in child protection and children's rights. Mr. Landry is a specialist in child protection. He was the Youth Mine Action Ambassador against anti-personnel mines (2002—2003) for UNICEF Quebec. Also, he was a Child Protection Advisor for the UN peacekeeping mission in the Democratic Republic of Congo, a Research Specialist and Project Manager in West Africa on behalf of the Coalition to Stop the Use of Child Soldiers, and consultant for UNICEF, the World Bank, the United Nations Department of Peace Operations, GIZ, Save the Children and the



Canadian International Development Agency. He became Director of Programmes and Development at the International Bureau for Children's Rights (IBCR) in September 2006 and was named Director General in April 2014. His background in child protection and child rights has seen him lead the implementation of programs in over 70 countries. He has also supervised, coordinated, and authored more than 50 reports analysing the status of children's rights worldwide, while he has built relationships in his collaboration with experts and stakeholders in local, regional, and international contexts. Mr. Landry's connection with ECPAT is not new, as he previously worked as a Regional Assistant for the Americas and the MENA region at the start of his professional career. Since then, he has worked tirelessly to ensure that children all over the world are protected.
