





# OPEN LETTER

## Joint Letter on Abolishing Statutes of Limitations for Sexual Crimes Against Children

We the undersigned are writing to express our deep concern that statutes of limitations on sexual crimes against children remain in force in many countries around the world. These arbitrary time limits deny survivors their fundamental right to justice and protect perpetrators from accountability.

Survivors of child sexual abuse and exploitation often need years, sometimes decades, before they are able to disclose what happened to them. Trauma, fear of stigma, social taboos, and lack of trust in institutions are well-documented reasons why disclosure is delayed. Yet when survivors are finally ready to speak, too many are met with closed doors: prosecutors cannot act, perpetrators go free, and survivors are retraumatised by being told "it is too late".

### The consequences are devastating. By enforcing these time limits, governments:

Silence survivors and deny them access to justice.

 Enable perpetrators to escape accountability, leaving them free to continue harming children.

 Undermine trust in justice systems and international human rights commitments.

There are encouraging signs of progress. The European Union has taken decisive steps to strengthen protections for children: in May 2025, Members of the European Parliament's Civil Liberties Committee (LIBE) voted unanimously in favour of abolishing time limits on the prosecution of sexual crimes against children across the EU. On 17 June 2025, European lawmakers reinforced this commitment by formally voting to abolish statutes of limitations for child sexual abuse and exploitation. This sets an important precedent for governments worldwide to follow.

Every survivor has a right to their day in court, no matter how much time has passed. Survivors should never again be told that it is "too late" to seek justice for the crimes committed against them.

### We therefore call on all governments to:

 Abolish all statutes of limitations for child sexual abuse and exploitation crimes.

• Ensure survivor-centred justice systems, with trauma-informed

processes that respect dignity, safety, and support.

 Reinforce commitments to children's rights, aligning with international standards including the UN Convention on the Rights of the Child and the ECOSOC Guidelines on Justice in Matters involving Child Victims and Witnesses of Crime.

The credibility of governments' commitments to children's rights and to ending sexual violence will be measured by their willingness to remove these unjust barriers. We urge you to act now—justice must never expire.
